Rules & Regulations:

1. A rental deposit (half of total) is required to book a reservation; rental must be paid in full at least 2 weeks prior to the date. Any cancellations or request for refund must be done in writing at least 2 weeks prior to the date. *Refunds due to cancellations will take approximately 4-6 weeks.*
2. All guests will receive wristbands for the rental and must be worn at all times inside the facility. All guests over rental limit will be charged regular admission entrance.
3. Cleaning fee must be paid the day of rental (CASH Only). Rental agrees to leave area in conditions received, in order to obtain the cleaning fee at the end of rental time.
4. The City of Miami is not responsible for any lost, damaged or stolen items.
5. *If the facility closes due to weather conditions, guests must leave IMMEDIATELY; a reschedule (pending availability) or a refund may be requested(in writing) if the use of the facility has not exceeded 3hrs. Refunds due to cancellations will take approximately 4-6 weeks.*
6. No piñatas, DJ's, water balloons, goodie bags, or costume characters.
7. No alcoholic beverages allowed.
