









- First purpose-built venue for powerboat racing in the United States.
- Dedicated as the Ralph Munroe Marine Stadium on December 23, 1963.
 - Stadium was built at a cost of \$1 million;
 - Basin was dredged for approximately \$900,000.
- The **6,566 seat** stadium was designed by architect Hilario Candela
- After Hurricane Andrew, it was declared an unsafe building under MDC building code and shuttered by the City of Miami on September 18, 1992.
- Designated historic by Miami's Historic Preservation and Environmental Board.
- Recognized as an architectural masterpiece by the National Trust for Historic Preservation. Named to the National Trust's 11 Most Endangered List in 2009.
- In 2009, **World Monuments Fund** named Marine Stadium to its 2010 Watch List (significant endangered sites).
- \$3 MM Miami-Dade County GOB
 - Approved by County Commission on 4-06-2010 via R-328-10
- \$45MM City of Miami Special Obligation Bond for the Marine Stadium & Welcome Center
 - Approved by City Commission on 11-17-2016 via RE 12-1230













Sec. 53-52. - Regulations generally.









In addition to any other laws applicable to the operation of the Marine Stadium, the following regulations are hereby established:

- (1) At times other than when public events are scheduled, it shall be unlawful to trespass on the water and land area comprising the city's Marine Stadium without written permission from the city or a properly designated representative thereof.
- (2) It shall be unlawful to bring canned or bottled goods into the Marine Stadium grandstand.
- (3) It shall be unlawful to build fires for any purpose at the Marine Stadium on land or in the boats.
- (4) It shall be unlawful to have an animal or other pet in the grandstand.
- (5) The following activities are unlawful on the land and water area comprising the Marine Stadium unless any of such activities has been specifically authorized: boat traffic, waterskiing, picnicking and fishing.
- (6) Other than the area designated for use by self-contained camper trailers, it shall be unlawful to park a motor vehicle, or to anchor, moor or dock a boat overnight anywhere in the Marine Stadium area or to use any portion or facility of the Marine Stadium for overnight lodging.
- (7) The public shall have access to the boat hoist and boatramp facilities at the Marine Stadium during daylight hours at times when events are not being conducted. There is hereby established a fee of \$5.00 as payment for the use of the boat hoist, but there shall be no charge for the use of the boatramp.
- (8) A land area at the Marine Stadium shall be designated wherein self-contained camper trailers may be parked and utilized for overnight loading at a fee to be established by ordinance. The city manager shall establish such regulations necessary for the control and management of this operation.

(Code 1967, § 2-48.2; Ord. No. 9449, § 1, 6-17-82; Code 1980, § 53-117)

Historical Background – Ordinances Impacting 53-52



October 2, 1963 – Ordinance 07157: Creates the "Marine Stadium Department"

July 17, 1967 – Ordinance 07580: Items from #1 to #6 from previous slide are incorporated into the City Code to establish additional regulations for the security of the area.

March 26, 1969 – Ordinance 07761: Item #7 is introduced to the City Code, to allow the public to access the boat hoist and boat ramp facilities at the Marine Stadium with a recommended \$2 fee.

April 22, 1975 – Ordinance 08403: Item #8 is introduced to the City Code, to allow supplemental uses of Marine Stadium complex to authorize for self contained campers.

April 14, 1982 – Ordinance 08470: Item #7 is amended to clarify; the use of the boat ramp is free and the \$2 charge if for the use of the hoist.

June 17, 1982 - Ordinance 09449: Item #7 is amended to increase the use of the hoist from \$2 to \$5 and no charges for the use of the boat ramp

March 26, 1969 – Ordinance 07761: Item #7 is introduced to the City Code, to allow the public to access the boat hoist and boat ramp

facilities at the Marine Stadium with

a recommended \$2 fee.

WHEREAS, public access to the boat hoist and boat ramp facilities at the Marine Stadium is not permitted under the present ordinance; and

OR N

WHEREAS, the Director of the Department of Publicity and Tourism has, after extensive study, recommended that the use of the facilities at the Marine Stadium under certain conditions be made available to the public at times when events are not being conducted;


NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. That Article IV of Chapter 2 of the Code of Laws of the City of Miami, Florida (1957) be and the same is hereby amended by adding to Section 2-48.2 entitled "Regulations Generally" a new paragraph numbered (7) to provide as follows:


(7) That the public shall have access to the hoat hoist and boat ramp facilities at the Marine Stadium during daylight hours at times when events are not being conducted; that there is hereby established a fee of \$2.00 as payment for the use of the boat hoist; that there shall be no charge for the use of the boat ramp; however, no overnight parking shall be permitted.

















April 14, 1982 – Ordinance 08470:

Item #7 is amended to **clarify**; the use of the boat ramp is free and the \$2 charge if for the use of the hoist.

WHEREAS, the said amendatory ordinance contained the follow-

ing sentence:

"There is hereby established a fee of two dollars as payment for the use of the boat ramp."

and the herein ordinance will correct the oversight and omission;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE

CITY OF MIAMI, FLORIDA:

Section 1. Subsection 7 of Section 2-48.2 of the Code of the City of Miami, Florida is amended to read as follows:

"7. The public shall have access to the boat hoist and boat ramp facilities at the marine stadium during daylight hours at times when events are not being conducted. There is hereby established a fee of two dollars as payment for the use of the boat hoist, but there shall be no charge for the use of the boat ramp.

Section 2. All ordinances, code sections or parts thereof in conflict, insofar as they are in conflict are hereby repealed.








Project Scope: Boat Ramp Proposed Plan

Best Management Practices:

On weekends, when the beach parking lots are full/closed, people park across the Marine Stadium and cross the Rickenbacker Causeway toward the beach parking lot.

Best Management Practices:

Key Timeframes - Weekend and Holidays Traffic

Crandon Marina Boat Ramp - Staff assist with traffic for the use of the park, County park rangers

Main issue: traffic on weekends and holidays. Traffic must be directed





Parking Needs and Traffic Management Plan

Best Management Practices:

- Entrance and informational signs to prevent visitors missing entrance
 - Adequate directional signage along the public roadways leading to the site. Directional sign placement outside of the facility should be based on the design speed of the public access road. Wayfinding signage for park patrons and boat ramp users should also be well placed and consistent







Best Management Practices:

- Maintain queuing area inside of the Stadium Complex
- Provide "prepping areas" or designated staging areas
 - Make ready area and tie down area An ideal facility will provide space adjacent to the queuing area for a 12 ft. wide x 60 ft. long "make ready" area to allow boaters to fully prepare their boats for launch at the ramp without holding up the queue line. Similarly, a 12 ft. x 60 ft. area for tie down adjacent to the drive aisle leaving the ramp is also preferred. This area allows boaters to prepare their boat for safe travel on public roads without taking up a parking space or blocking drive aisles.
 - 25% parking is for patrons not towing boats





Parking Needs and Traffic Management Plan

Best Management Practices:

- Access control for areas outside designated parking
- Provide "prepping areas" or designated staging areas
 - Establish control either by landscape features or bollards, fences, etc.
 - Removable feature for flexibility in the area
 - Movable planter as per CIVITAS Flex Park Schematic Design (Typ. RE: DTL 9/L – 501)








- Water

Reservation System

- Pros
 - Reduce traffic on Rickenbacker Causeway
 - Guarantee boaters will be able to launch
 - Informs boaters on closure of ramp in advance
 - No queue lines on Rickenbacker Causeway
- Cons
 - Limits parking to only reservations
 - Additional operational cost

No Reservation System

- Pros
 - Early bird guaranteed to launch
 - Simple system, as other ramps

- Cons
 - No control on Rickenbacker Causeway traffic
 - Queue lines with boaters waiting for ramp to reopen
 - No way to inform boaters on closure of ramp





- Boat ramp hours of operations: From sunrise to sunset, when there are no events booked on Stadium and Site
- Parking rates: TBD
- No commercial charters allowed.
- No pick up and/or drop off.
- Boats to be launched shall not exceed 40ft in length. Larger boats will be PROHIBITED.
- All vehicles pulling trailers must park in trailer parking designated areas only.
- *All vehicles pulling trailers MUST have a reservation.
- *Boat trailer parking without reservation is strictly prohibited.

- Note:
 - Failure to follow the rules will result in vehicle being towed from the Miami Marine Stadium site.
- * Applicable only if a reservation system is applied.

- -Special Certificate of Appropriateness requested by the Historic Preservation Officer due to the historical location of the project
 - -Approval required for any major alteration, addition, or new construction for a historical site. This process is to be for HEP to approve, deny or defer. They can also approve with conditions.
 - -Specific to HEP is the review of the boat ramp and the docks, not the parking lot.

PZAB – To be presented December 21, 2022

- -Exception Process Extension of the ramp into the bay triggered this process.
 - -Comments from Planning, Zoning and Environmental Resources were made at a pre-application meeting on Tuesday March 8, 2022.


