ACA Ferguson expressed an objection to the request before the Board citing a lack of due process, particularly in the employee knowing what he has been charged with and why, and having the opportunity to challenge the charges. Attorney Rind responded that if the request is granted, that the Board could recommend redress.

Chair Sutton, Member Cabrera, Executive Secretary Mindingall and Special Counsel Dyer each provided input regarding the purview of the Board and the method of and schedule for conducting the preliminary investigation and 16.1 hearing.
