Adanna Ferguson, Assistant City Attorney, appeared before the Board and stated that she received a copy of the Appellant's proposed Findings of Fact and request the Board to deny the Appellant's version of Findings of Fact. ACA Ferguson referred the Board to page 18 of the Civil Service Board Manual of Procedures, which state the following, "It is the responsibility of the Boards Special Counsel to complete and submit Findings of Fact within a reasonable amount of time to the Civil Service Board following an appeal hearing. The Findings of Fact must be based upon substantial competent evidence and supported by evidence in the record. A conclusion by itself is insufficient. These facts must be supported in the Findings of Fact and recommendations, which will support the final Judgment which will be signed by the City Manager." ACA Ferguson went on to ask the Board to adopt Special Counsel's version of Findings of Fact and Conclusions of Law.
